Subject: Regarding Procurement Process under STRIVE.

Kindly refer to the subject cited above.

As you are aware that on receipt of a complaint regarding adopting improper bidding process for procurement of different type of items, instructions through email dated 02.12.2022 were given to you to put on hold the ongoing procurement process till further orders. Various bid documents received from STRIVE ITIs have been examined by the directorate and it has been observed that various small tools, equipments, heavy machinery items, furniture and computer items etc. have been included in one bid by some ITIs which is not appropriate and will lead to irregularities in purchase.

In view of this, you are directed to

1. Ensure to prepare the bid document for procurement of items after categorizing the required items sector wise like Electrical, Mechanical, Electronics, IT sector etc and further categorizing the items in small tools, medium, heavy machinery, IT and furniture items etc. ***It is to be ensured that small tools, equipments, machinery, furniture and computer items etc are not be included in one bid document and separate bid document is to be prepared for every category of similar items.***
2. To cancel all previous processed Gem bidding/e-tendering process immediately and prepare the new bid documents as per above categorization of items and obtain the prior approval immediately from the Directorate before publishing the bids.

If any irregularity is found in the procurement process then strict action will be taken against the concerned Head of the Institute.

This is for your information and immediate necessary action.
